In fact, we have found that more subscribers are reading more of the material that we print. Maybe a few pages have been overdesigned. Please allow us a few growing pains as we continue to develop our new design and editorial content.

Gentlefolk:

Why is it that it is easier to blast something we don't like than to praise something we do? My theory is that if we like it we take it for granted, because of course that is the way it is supposed to be anyway. I can't say I don't miss the old format of *Skating*, but I'm in that 60 and over category and we like to keep things the way we're comfortable with. I hope the input you get from us readers will enable you to put something out that everyone can be more or less comfortable with.

In general, I like the articles. I even like the ads, because they keep the flavor of skating, usually. Thanks especially for the write-ups on Rudy Galindo and Nancy Kerrigan and the critiques of several skating events in the December issue.

Like many others of your readers, I suspect, I am less than contented with the aesthetic concepts of the page set-up person, as contrasted with the editorial content. Without going into detail, I would have thought there would be no question of trying some of the effects attempted, they are so obviously wrong. These visual effects are "reader unfriendly." There ought to be—if there isn't—a fundamental law in the printing profession that there has to be a contrast between print and background. Further, look at the headline on pages 32 and 33. What clue do we have that we're supposed to read it "Former World and Olympic Medalists Dominate" instead of from the top down?
