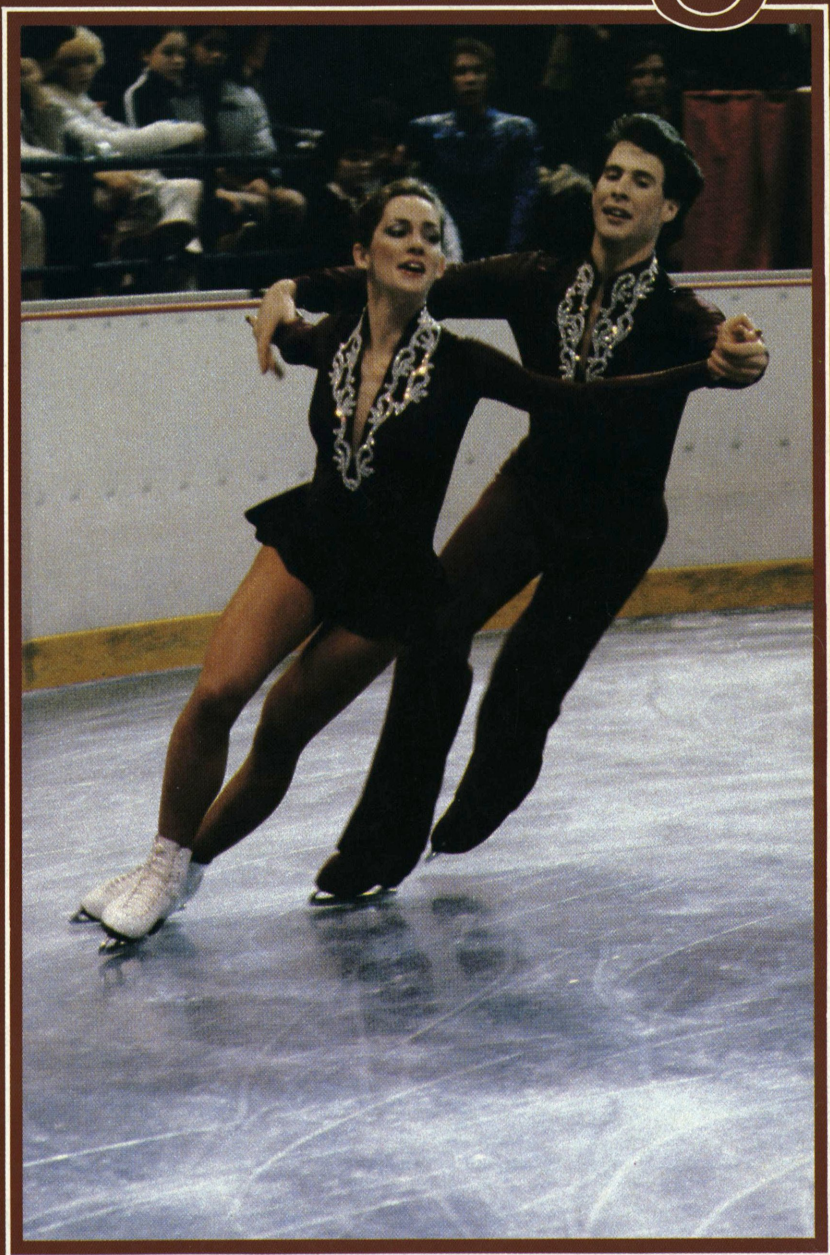

# ICE ABROAD

## U. S. TEAM WIN ENNIA CUP IN THE HAGUE

The four day Ennia Challenge Cup internationals in The Hague, Holland, ended on a high note for the American squad. The U. S. were decisive winners of the team trophy, with Great Britain runner-up and West Germany third.

This distinction was clinched on the final day with a second place in the men's event by the greatly improved Mark Cockerell. The other national skaters whose performances counted towards the team points—nominated beforehand from any three of the four events were Jackie Farrell, who had earlier won the Ladies, and Peter and Caitlin Carruthers, second in the pairs.

This fifth annual Ennia meeting, efficiently and enthusiastically organized, attracted a record entry of 96 skaters from 19 nations to the city where the International Skating Union was founded in 1892—in the very hotel, the Kurhaus in Scheveningen, where all the competitors and officials stayed.

Fifth in the Ladies' short free, Jackie Farrell stormed through in the long for a narrow verdict over the East German runner-up, Katarina Witt, who ranked tenth in the world. The Japanese, Megumi Yanagihara, who gained a special award as the most promising newcomer at the meeting, denied third place to Britain's Karen Wood, who had led the field in the short free.

Jackie struck peak form with three triples—two Salchows and a cherry. Katarina began by attempting two triple cherries, but missed the second. Bucharest-born Simone Grigorescu two-footed a triple Salchow, but was quite an impressive fifth for the U. S.

Peter and Caitlin Carruthers just failed



to catch the West German pairs winners, Andreas Nischwitz and Christina Riegel, in a neck and neck finish. But for a mild collision and touch-down by Peter, the U. S. duo, fifth in the 1980 Olympic Winter Games at Lake Placid, displayed the extra polish one would expect, with excellent musical interpretation, strong lasso lift, twist lift and throw Axel.

Robert Daw and Susan Garland, the third-placed British pair who train on the same Wilmington rink as the Carruthers, showed to be, at sixteen and fourteen, quickly improving prospects. Their death spiral in particular was so much better than they knew how a year previously.

Jean-Christophe Simond, the Frenchman who came fourth in a powerful Skate Canada entry a fortnight earlier and was seventh in the Olympics, was another to hit top form, which was timely because Mark Cockerell finished very strongly, rising four positions to pass the third placed Canadian, Daniel Beland.

Simond included four triples—two cherries, a Lutz and a Salchow, but Mark landed six—two Salchows, two cherries, a flip and a Lutz. The very athletic Californian, who held the Junior World title in 1976, is a powerful jumper but his presentation was his weakness and this was indicated in his second set of marks.

Tall, lanky Jim White had looked good in the short free, cleverly combining double loop and triple toe, but appeared overawed in the final session and this is how these major non-championship internationals can lend valuable big-time experience. Jim did enough to show he is on the way up.

Two Russian couples proved superior in the ice dance, Moscow's Andrei Bukin and Natalia Bestemianova finally edging out their compatriots, Rotislav Sinitsyn and Natalia Karamysheva.

Steve Williams and Wendy Sessions overtook a Czechoslovak couple, Jan Bartak and Jana Berankova, to capture Britain's second bronze medal of the meeting. Wendy was Junior World champion in 1978 with her former, Mark Reed.

Seventh placed Scott Gregory and Elisa

Spitz looked to have a bright future. Their set pattern dance to cha-cha-cha rhythm matched the music much better than many of their rivals and their free dance was entertainingly innovative.

Lawrence Demmy, the ISU dance referee, confirmed that the ice dance entry of fifteen nations was the largest year of any senior international championship or competition.

## THE 1980 BRITISH CHAMPIONSHIPS

The new ISU results system produced identical and dramatic reversals of fortune in both singles events when the British figure-skating championships were held at Richmond ice rink, London, on December 3 and 4. In both men's and ladies' events, the skaters who proved outstanding in the compulsory figures and short programs and who, under the old rules, would have built up unassailable leads, found themselves only second in the final results because of a quirk in the rules.

Among the nine contestants for the ladies' title was Deborah Ann Cottrill, eighteen year old former champion who had been beaten in 1979 by Karena Richardson. With Miss Richardson now a professional, the way seemed clear for Miss Cottrill's reinstatement as Britain's leading skater. Ninth in the last World champion-

ship, she is a good all-round skater whose training plans suffered a setback last fall when doctors diagnosed a stress fracture in her right leg.

At Richmond she seemed to have made a good recovery. On the figures, she had no rival, and built up a lead of almost twenty-two points (between 2.4 and 3.1 from each judge) over the runner-up Karen Wood. Under the new system, however, a lead in one part of the championship counts for nothing; it is the fact of being first that matters, whether by an overwhelming advantage or merely by a whisker. But Miss Cottrill looked well on her way to the title when she gave a graceful performance in the short programs, with a fine double Axel and double Lutz/double loop combination. Last year Miss Wood had attracted attention with a crisp triple



Salchow/double loop at this stage, but now she contented herself with the same combination as Debbie. Miss Cottrill won this part of the championship by a 7-to-2 majority. This, with her figure victory, gave her a perfect score of 1.0 at this stage, with Karen Wood second with 2.0. There was a tie for third place between Lynne Rickatson and Alison Southwood on combined figure and short results.

Next night, Karen skated ahead of Debbie in the draw order. She opened with a good triple Salchow and triple toe-loop. A tall, athletic girl, she jumped high and confidently. The program included an Axel/double cherry flip combination, triple loop (not quite steady), a double Axel after which she just touched the ice with a steadying hand, and another triple toe-loop. It was a grand program well skated to tuneful music, ending with Cushley and her brother Neil, thirteen.

Suppe's exhilarating "Banditenstreich" overture which was used to such brilliant effect years ago by the former World pair champions Marika Kilius and Hans-Jurgen Baumler.

Debbie Cottrill followed her chief rival. She fell on her very first jump—triple toe-loop—and turned her triple loop into a double. She stumbled on another triple cherry, and although she gained marks for artistic impression, she could not match Miss Wood's technical merit. Karen won the long free by 5 to 4.

The new results system thus produced a tie. Debbie had  $0.6 + 0.4 + 2.0 = 3.0$ ; Karen had  $1.2 + 0.8 + 1.0 = 3.0$ . The rules now say that in these circumstances "the best placement shall be decided on the basis of the lowest ordinal for free skating." This gave Karen the title.

This cheerful blonde, eighteen year old from Gateshead, Durham, has had quite a remarkable career. At the age of thirteen, she was British junior pair champion with Stephen Baker; in 1979 she won the junior singles championship, and in November 1980 she became the first British skater for twenty-five years to win the Richmond International Trophy.

The men's championship produced a similar result to the ladies' event. Andrew Bestwick won the figures by a handsome margin, and all except one judge placed him first in the short free. In the long programs, it was a different story. After a good triple Salchow, Bestwick two-footed his triple toe-loop and tried no others; his double Lutz was also landed on two feet. Christopher Howarth, in contrast, gave one of the best performances of his life. He opened with a series of jumps which included a high double Axel, triple toe-loop, and triple Lutz (he just managed to hold the landing edge), and won the long free by five judges to two. As in the ladies' event, there was a tie in the overall results, and the long free result prevailed.

The pairs' championship produced a unanimous verdict in favor of Susan Garland and Robert Daw, title-holders since 1978 and winners of the international Nebelhorn Trophy at Oberstdorf last summer. There were good performances from all four pairs, and the crowd particularly liked the extrovert eleven year old Lisa

# PATCH

## A LETTER TO MY STUDENTS

Dear Skaters:

First, I want to welcome you to one of the most frustrating, difficult, and depressing sports there is. Also, one of the most rewarding, interesting, athletic, aesthetic, and addictive. You are going to have marvelous successes, earth-crashing failures, and periods of emotional highs, as well as depressing lows, in the years to come. My advice to you is to stand tall, keep smiling, and not to be content with almost—or second best. As you keep striving for perfection, you will improve, however, you will never be as good as you want to be. . . . Stand up for your rights and be strong without being belligerent and bossy.

*Competitions:* Most of you are striving for a successful competitive career right now as well as completion of the eight tests. Learning to “compete” is just as important to you as learning an axel or a new figure. Remember, in competition you don’t need to “beat” anyone, only yourself. If you compete and skate your best then you have a personal win. If this win, if your very best effort isn’t good enough, you know you have to work harder. There is more to life than winning, however, and it’s up to you to find your

own set of goals and values. This way you’ll never be the loser. This does not mean I don’t care if you win or lose! You are my students and I want you to get out there and tear up the ice! Skate your best and skate to win! When you compete you will travel to new places, skate in different rinks and meet many new friends. When it’s all over, make sure you compliment the winners and console the losers!

*Hard Work:* Most of you do now know what hard work really is. A desire to become great is your guideline and the toll this dedication takes on you is what makes dreams reality. Pushing your body beyond endurance; working so hard your legs wobble when walking out of the rink; rivers of sweat down your back; ruddy, red faces. . . that’s working. Standing in groups, complaining, whining, and gossiping is going to get you nowhere. Be straightforward and realistic about yourself and your skating, and be brutally honest with yourself.

*Patches:* First, layout one of your test figures (or competition as the case may be). Correct this layout with the scribe and skate on the correction. Work on the parts of your figures (center, thrust, step-downs, turns) which refuse to get right. Do not go round aimlessly in circles retracing errors. When your clean ice is used up, practice form and positions which you can’t master.

*Lessons:* Plan ahead of time to ask questions and bring up problem moves. Let me know of anything which is going wrong (or right!) with any part of your skating. If you don’t understand my explanation tell me. Remember the points I bring up in your lesson. You can bring a notebook in your skatebag in which to write down instructions and new ideas, programs, things to remember, dates.

*Freestyle:* Stretch at the board. Stroke at least fifteen laps—forward, backward, figure eight and serpentine patterns. Then get to work. Warm up on the jumps and spins you have, then straight to new moves. Intelligent practices will improve your skating. Run through the program once (twice if possible) with the music

## A TRIBUTE IN CRUSHED ROCK



What started out as landfill for a gulley ended up a tribute in stone from a proud mother to her skater son. The mother is Mrs. Annette Cramer of Colorado Springs, the son Scott Cramer.

It took a month's hard work and about 2,000 lbs. of crushed rock to finish the two figures.

The idea came to Mrs. Cramer when she was landscaping the landfill at the side of her home. "Doodling", if you will, with the crushed rock she was using, she first fashioned the "80", then the skate, and then came the brainstorm for Scott. As Mrs. Cramer says, "The idea was easy, but implementing the idea in stone was another matter."

An accomplished artist in her own right, Mrs. Cramer worked from photos and her sketches to get the layout she wanted. Outlining the figure on the ground was difficult.

The first figure, the blue one on the black background, was outlined in flour that trickled through a hole in a bag, an ingenious idea that was received with much delight by the local ant population, which

carried poor Scott off grain by grain faster than Mrs. Cramer could lay down the outline. Undaunted, Mrs. Cramer fought back and finished the job ahead of the ants. The finished crushed-stone figure is slightly larger than lifesize and stands out in relief from the background, creating an animated, dimensional appearance.

The second figure benefitted from the experience gained. This time, the outline was marked out on plastic fastened to the ground. No ant problem, but when a windstorm suddenly sprang up, a spreadeagle was necessary to save the day.

Intriguing touches on the second figure include an actual skate belonging to Scott, and eyes of blue stone donated by the Cramer's neighbor who personally dug them out of the San Juan mountains. Apparently, true blue stone is hard to come by. Crushed road reflectors put the finishing touches to the trim on the costumes.

"I must have lost ten pounds running up and down the stairs to get a perspective view of the developing figures," says Mrs. Cramer, "plus I'm constantly keeping

a watchful eye out for dogs who love to scratch around in the stones, and Bluejays who have a fascination for Scott's blue eyes. I often find them scattered around the yard."

The fascination for the design is growing. Dr. Lester Cramer, and Pieter Kollen, former U. S. Pair Champion, have designed a "mathematically perfect" double loop for the bare patch above the figures.

"It's their turn now," says Mrs. Cramer, "I'll sit back and see what they can do with the ants, dogs, Bluejays . . ."

Dr. Lester Cramer is a Gold Test and Silver Dance Judge, and Annette Cramer is a Silver Dance Judge. Scott Cramer was an amateur competitive skater who logged up an impressive record in his twelve years of skating, beginning in 1969 when he placed first in Intermediate Men, and culminating his career by placing fourth at the 1980 Nationals. He turned pro in 1980, and is presently studying pre-med at USC in California.

### LAS VEGAS FSC SPONSORS SKATING OUTING FOR THE BLIND

On Sunday afternoon of November 9th, members of the Las Vegas FSC entertained a very special group of children at the Iceland Center, 704 Sunset Rd., Henderson, Nevada.

Early in September, Mr. Douglas Hichman, President of the Las Vegas FSC, Mrs. DeVoree Ober, teacher at the Las Vegas School for the Blind and Mrs. Joyce Janssen, Program Director for Iceland, met to put together the first of the Club's volunteer events for handicapped children.

It was decided that twenty figure skaters would take twenty blind and partially sighted children from the blind center, ice skating. Each figure skater would have as their special guest, one student for an afternoon of skating and refreshments.

All the skaters contacted felt that it would be a challenging and exciting experience and responded with enthusiasm. Parents, members of the foundation, and skaters, all working together, combined

to make the ingredients for an enjoyable and successful afternoon.

We wish to thank all of the people involved, and most especially the figure skaters for giving of their time and talents for the enjoyment of other young people.

**Jenny Nicks**, former World, European, and British pair-skating champion, died on August 21 of a heart attack at her home in Canada, aged 48. She was christened Jennifer Mary, the daughter of two Sussex athletes, Jack and Elsie Nicks; she was also great-great-niece of John Wisden, a pioneer in Victoria times of the English game of cricket. She and her brother John were good solo skaters; John was British Junior Men's champion in 1947 and Jenny was runner-up for the Ladies' title two years later. It was as a pair, however, that they had their greatest success. Trained by the renowned ice dance coach, Gladys Hogg, they won six British national pair titles between 1947 and 1952. They competed in the 1948 and 1952 Olympic Winter Games, only missing a bronze medal by one place in the latter year. In 1950 they were runners-up for the World pair championship, won by Karol and Peter Kennedy of the USA. Their best year was 1953. At Dortmund, they became champions of Europe, and two weeks later took the world title at Davos—the only British pair to win since 1912.

They then turned professional. Jenny won the British Open professional women's figure-skating championship in 1955 and 1956, and later she and her brother appeared in a show in South Africa. She suffered a mild heart attack there, and gave up show skating. In 1959, in Southern Rhodesia (now Zimbabwe), she married a Scottish civil engineer, Stanley Hunter Sturrock. His work took him to Canada, and they settled in Delta, British Columbia. Their two children were Canadian-born; one of them, Samantha Sturrock, is herself an ice-show skater.

Jenny became a teacher of skating, and in 1979 came to Britain for the centenary gala of the National Skating Association at Wembley; in company with other British world champions, she was presented with a special commemorative medal by Queen Elizabeth II, who is the Patron of the NSA.

# the Spirit of Wilmington

It's a place, it's a rink, it's literally a moving force whose spirit permeates the very life and soul of the competitive dancers and pair skaters who make up its physical embodiment. It's the competitive figure skating lifestyle as it should be at it's best, full of closeness and competitiveness, drive and friendship, physical prowess and carefully nurtured stamina.

Its capacity for pure physical movement can be felt as wind whistling around a bystander's ears as the spirit, all fifty components, takes the ice for the nightly power stroking session. Its mentality can be felt in a quiet brainstorming session where each component searches himself for answers to some hard questions about his or her sport. Its spiritualism shows as one team helps another with a difficult

move, even though they compete directly against each other. Its emotional involvement can be felt at rinkside during Easterns or Midwesterns or Nationals, when fellow Wilmingtonites show up en masse to cheer for each other. Its heart can be seen in the solid friendships that bloom and flourish, even amid the hectic lifestyles competitive skaters seem to thrive upon.

It happens at the Skating Club of Wilmington, perched high on a Delaware hill, overlooking the sparkling lights of the Delaware Bay and the distant New Jersey

shoreline. It's a bustling rink around the clock, by day full of patchers and singles skaters, group lessons and open sessions; by night changing character dramatically, playing host to the "night skaters of Wilmington," six nights a week, ten months a year.

They come from three countries and sixteen states, these night skaters of Wilmington. Their skating expertise ranges from newcomers in competitive Novice Dance to experienced world team Gold dancers and pairs. They've won everything from Cleveland Invitationals to a place on the Olympic teams of two countries. They come from everywhere—California, Michigan, Tennessee, Canada, England—to live and work and go to school in their adopted city. They live in apartments, houses, or with skating families, work in fast food restaurants and computer centers, go to classes at Drexel, the Universities of Delaware and Pennsylvania.

But the driving force—the common denominator, the *raison d'être*—is the four to six hours spent training nightly at the rink, doing the one thing they all have in common: working hard to make it to the top in competitive skating, trying to be Number One. They all have that competitive spirit, to be sure, but the spirit they like to talk about both encompasses and exceeds that desire to win.

What makes Wilmington so special?

"We have a team spirit," dancer Jock Kohlas says during a recent 2:00 A.M. group question-and-answer session. "We're the Wilmington team." Heads nod around the room. Everyone starts to talk at once. John Summers, 1980 U.S. Dance Champion, explains: "What makes Wilmington so special is the kids. It's unusual to find such closeness outside skating. We get to see everyone at his worst and at his best, and we accept that and like each person for what he is." Brother Frank Summers agrees: "We work so closely here for so many hours a day—you *have* to get to know everybody so well. It's a great atmosphere here—inspiring to be able to work with a lot of the top people in your sport."

Pacific coast pair skater Cara Gill chimes in: "We get to be closer to our friends here than our friends outside skating." Illinois dancer Janice Kindrachuk agrees: "When I go home, I leave a little of myself here." "We always heard of 'Luddy's Army'," international and world team dancer and newcomer to Wilmington Carol Fox laughs. "And for years we've watched Wilmington skaters stick together. We're pleased to find such a good feeling here. We were accepted right away." "People kept telling us about Wilmington skaters," British Pair Champion, Robert Daw, says quietly. "It's all true."

This delicate balance between driving competitiveness and friendly helpfulness didn't just happen. It has been carefully nurtured for years by the man who is the reason why these skaters leave home and flock to the Skating Club of Wilmington. His influence and presence are formidable, his manner understated, his talent for both on-ice technical teaching and off-ice impartiality unbelievable. He is psychologist, prime mover, source of inspiration, and coach of all twenty-five teams: four-time U.S. Pair Champion and Olympic Bronze Medalist, Ron Ludington.

His students talk about him with a respectful reverence. "He makes you want to just always do your best," dancer Blake Hobson says emphatically. And he does it with a quiet coaching manner finely honed over the years. "He will not push you," Olympic pair skater Peter Carruthers says, "you push yourselves."



"He forces you to be more independent," dancer Sonja Kenney adds, "learn to make your own decisions about your skating."

There are two things about the man that long-time Ludington-watchers immediately agree upon: he handles and teaches each of his dance and pair teams differently, and he does it, even in the face of increased pre-competition tension, with total impartiality.

Does he consciously decide how to handle each team?

"Yes, very definitely," the red-headed ex-roller skater, ex-ice skater says emphatically. "I like kids and I can identify with them. I figure out the best way to talk with and teach them, and I take it from there. If they're totally serious and dedicated, I treat them seriously. If teasing works, I can just run away with that." He laughs, remembering. "I try to make it fun."

Ron Ludington's involvement in the skating world didn't start as a fun thing. "I was getting in trouble on the streets at age ten," he says, "so my father sent me to the local roller rink to keep me out of trouble." From there it was street energy turned to sports energy, and the young roller skater went on to win national titles in both pairs and men's singles. At age nineteen, and already a professional coach, one of his competing students visited an ice rink, loved it, got his coach to exchange wheels for blades, and the transition to ice began. But not as total involvement, not just yet. Ludington, in addition to all the time spent on ice, continued his music—he played the trumpet professionally for ten years ("I never pick it up now—no time")—and went on to Northwestern University with dual majors in engineering and design, emerging to work designing computers.

His love for ice skating was never more than just below the surface, and he quickly became one of skating's bright promises, winning both Junior Pairs and Silver Dance, bronze medals in Gold Dance, and a fourth place in Novice Men. He, along with partner, Nancy Rouillard (Luding-

ton), won the U.S. Senior Pairs Championships four times, were Bronze medalists in Worlds in 1959 and Olympic Bronze medalists in 1960. Not content with that collection of amateur laurels, he won the World Professional Dance Championships in 1965.

Today, still red-headed and freckled, and balding just a bit, he copes with the nighttime schedules and recurring back problems that cold ice rinks just don't help. A typical night session on the Wilmington ice finds the leader of "Luddy's Army" seated behind a small space heater at the far end of the rink. Every one of his students *knows* he doesn't miss a trick, and his total absorption in the team he's teaching at the moment does not preclude a sidelong glance at the Carruthers' lateral split triple twist or the Todaro's throw double Salchow.

Don't twenty or more pairs and dance teams on the ice at one time, along with their knife-sharp flashing blades, pose too much risk at one time for one rink surface? "The possibility of another ice sheet here is in the talking stage. We can't grow as a training center without a second surface—we just couldn't handle it." He flashes a grin: "Maybe then I could even teach in the daytime."

Did Ron Ludington plan for Wilmington to become the pair-dance capital of the East? "It just kind of happened," the coach of some twenty-eight U.S. and Canadian champions says. "I came here ten years ago from Detroit with forty skaters, some of them World team and Olympic quality skaters. So we had potential from the beginning."

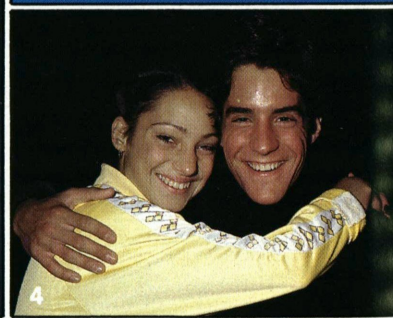
Ron Ludington's ability to teach technically perfect pair and dance maneuvers on the ice has been tempered and honed with the emergence of figure skating as a well-publicized and respected sport. What are the qualities that make up today's ideal pair team, today's ideal dance team? Is there a difference?

"In general," former pair skater and dancer Ludington replies, "pair skaters are more daring, and dancers," he pauses and smiles, "are more sophisticated. Of



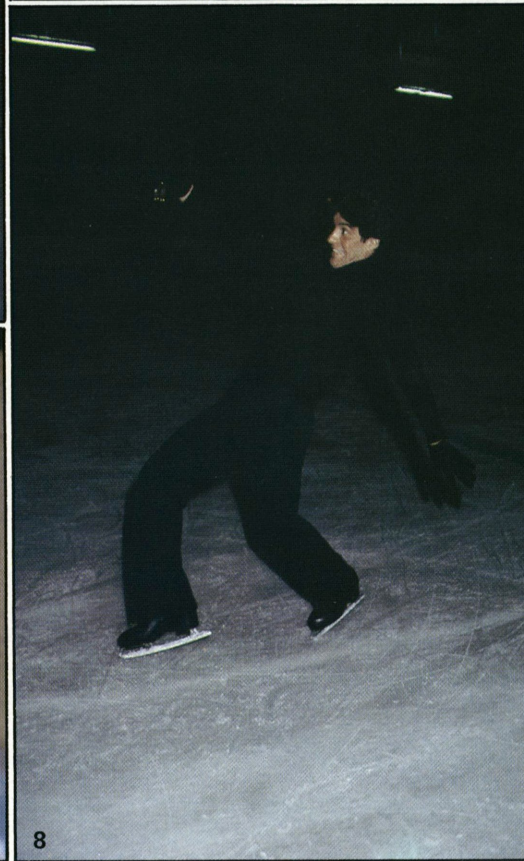

course, it all depends on the definition of 'ideal.' In both, tremendous discipline is absolutely necessary. In pairs, the boy must be physically strong, but the two have to become a skating unit. They, like dancers, have to be unified, skate *together*." He pauses, thinking. "Dancers must be extremely lyrical, musical; they have to have good soft knees."

Everybody knows that skaters have parents. What makes an ideal skater's parent?

"Somebody who completely trusts his child's coach," Ludington replies quickly and with typical total conviction. "Every kid is different. Some parents I encourage to push their skater, some I don't." He stops, says quietly: "Coaching is a lonely life sometimes. I don't socialize with my parents or my kids, sometimes I'd like to. But if I socialize with one, I must with all the others. . ."

That doesn't stop, however, the camaraderie and verbal bantering that flows from student to coach, and vice versa. Somehow the coach is friend, too, and this particular coach has been known to care very much indeed about his skaters in competition, and to show it.

A lot of observers think Wilmington skaters are exemplary of how competitive skaters should be. What does Ron Ludington think he has contributed to that?

"Well, first of all," says the man who coordinates all the diversified talents and personalities with a surprisingly relaxed ease, "this is a particularly good group. Then too, by having them all here every night," he laughs, "I keep them out of trouble and goal-oriented. They're too busy to be anything but nice kids!"

Being a member of "Luddy's Army" has other advantages too. Several of his pairs are the demonstrating subjects in a new ISU teaching film, and they recently skated in group numbers in Madison Square Garden's "Superskates" and in

Washington D.C.'s, "Ice Stars." And the solid feeling that comes from having the famous man standing at rinkside just before skating a competitive program must warm the heart of every one of his students. Each one of them is out there doing it for himself, but a small piece of that desire to win must have Ron Ludington's name stamped on it.

The sun has been to bed for hours in Wilmington, Delaware. Car headlights begin to pick their way down the winding road to the rink. Skaters emerge, shouting hello's to each other, carrying skate bags and sweaters. The Amarals come from an evening class at the University of Delaware. Carol Fox arrives straight from her job at a nearby restaurant. Jay and Lynn Freeman rush in after their nightly hour-and-a-half drive from home in New Jersey. Sue Dymecki comes in rubbing sleep from her eyes from a quickly-grabbed nap. They congregate in the upstairs lounge for forty-five minutes of off-ice lifts and warm-up exercises and teasing, friendly banter. Somebody asks Lynn Freeman if she's grown any today. Somebody else asks Jeff Nolt if *he's* grown any today. Suddenly, someone yells, "It's time!," and the rush to pull on skating boots and leg warmers begins.

Fifty skaters take the ice. Ron Ludington settles in behind his heater. Somebody puts on a loud rock record to stroke to. The wind whistles as all fifty gather speed.

The spirit of Wilmington is on the ice. . .

## “Hartford Welcomes the World”

“Hartford Welcomes the World.” It’s a greeting visitors to the 1981 World Figure Skating Championships will see on flags flying over Hartford’s streets, on banners at Hartford’s Bradley International Airport, in lights at the Hartford Civic Center, on posters around town and on bumper stickers on private passenger cars. Hartford will even change the name of one of its main thoroughfares from Asylum Street to “Avenue of the Worlds.”

Connecticut’s capital city is eagerly waiting the arrival of the world’s best figure skating talent. Greater Hartford’s appetite for competitive figure skating was stimulated by the 1977 U. S. Figure Skating Championships held in the Veterans Memorial Coliseum in Hartford’s brand new Civic Center.

Hartford is known as the nation’s insurance capital with twelve major insurance companies headquartered there. Insurance and figure skating, however, are no strange marriage. At The Travelers, co-sponsors, with the Skating Club of Hartford, of the 1981 World Figure Skating Champion-

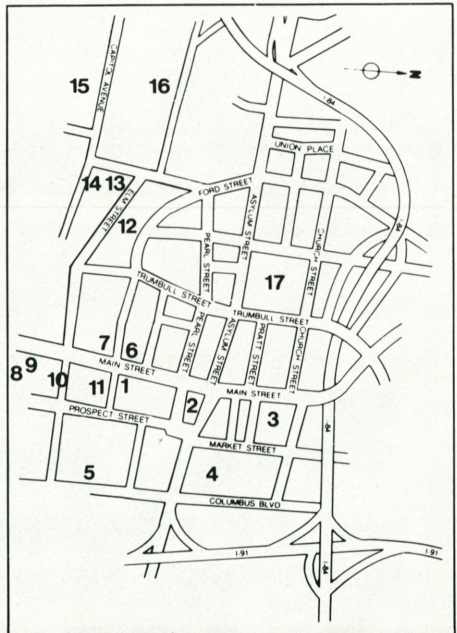
ships, sports and physical fitness have long been a focus of public service programming as an outgrowth of the company’s orientation as a major life and health insurer. Recently, The Travelers became the first corporation to form a major commitment to competitive figure skating when it entered into an agreement to sponsor the 1981 National Figure Skating Championships with options to sponsor the 1982, ’84 and ’85 nationals.

For visitors to the 1981 Worlds, The Travelers Tower will be the most visible mark on the horizon. Its 527-foot tower, tallest point in the city, looms over a vibrant, modern city cognizant of its colonial heritage. An exciting potpourri of places to go, things to see and activities to enjoy are available right in the shadow of The Tower.

In an afternoon walking tour of Hartford beginning at The Travelers, you might walk north one block on Main Street to the oldest statehouse in the nation. Designed by Charles Bullfinch in 1792, it is a registered National Historic

Landmark where Connecticut's Fundamental Orders, forerunner to the U. S. Constitution, were drafted. Through its halls, U. S. presidents and great figures in world history have walked. In its chambers, signers of the Declaration of Independence and a chief justice of the U. S. Supreme Court served as state representatives.

Further north on Main Street lies the Richardson Building, designed by Henry Hobson Richardson, one of the great pioneers of contemporary architecture in America. Last year, it reopened after extensive renovation as a residential and shopping complex with more than thirty specialty boutiques and eateries.

Exiting from the rear of the Richardson and crossing Market Street, you will find Constitution Plaza, Connecticut's first major urban renewal project. Rising from its modern granite mall are contemporary office and banking facilities, a broadcasting center and the Hotel Sonesta.

At the southernmost point on Constitution Plaza lies The Travelers Plaza. If you walk west, past the Hartford Club, along Atheneum Square North, you will discover Center Church, established in 1636 with Hartford founder Thomas Hooker as pastor. He and other Hartford pioneers rest in the Old Burying Ground behind the church.

Proceeding south, past the Bushnell Tower, designed by the architect I. M. Pei, and across Main Street at No. 396, you will find the Butler McCook Homestead, an 18th century home and gardens. On view inside are antiques from the McCook family and the colonial and Victorian periods.

Heading north on Main Street, you'll pass Hartford City Hall and the Burr-McManus Memorial Mall dominated by Stogosaurus, Alexander Calder's giant stabile. Next to it lies the five-building complex of the Wadsworth Atheneum, first free public art museum in America. Its sixty-five galleries house fine art collections ranked in the nation's top ten.

Across from the Atheneum and down Gold Street, you'll approach Bushnell Park. One block south of its southwest

corner, past the State Treasury Department, is the Bushnell Memorial Hall. Its interior is a rare example of art deco design. Its 2,728-seat auditorium, acoustically renovated in 1974, makes it one of Hartford's finest facilities for theatre, symphony and opera.

One block west on Capitol Avenue, the State Library contains relics of Connecticut's history, including 1,000 Colt firearms manufactured in Hartford, Indian artifacts and Gilbert Stuart's portrait of George Washington.

Across Capitol Avenue, the State Capitol, seat of government since 1878, contains statues, mementoes and art that memorialize Connecticut's History. When the Governor is in the building, the state flag flies over the west wing.

Several of Hartford's most precious attractions are a short bus ride from the center of town. The Mark Twain and Harriet Beecher Stowe homes are located at Nook Farm at the corner of Farmington Avenue and Forest Street. Twain lived in this unique structure modeled after a steamboat's pilothouse for twenty years while he wrote seven major works. Stowe's 19th century cottage appears as it looked when she lived there.

Further west on Farmington Avenue is the Children's Museum and Planetarium with displays covering biology, zoology, geology, mineralogy, paleontology and meteorology. It also features an aquarium and planetarium. The Connecticut Historical Society at 1 Elizabeth Street, at the corner of Elizabeth Park with its famous rose gardens, contains exhibits of American portraits, miniatures, 18th century imprints and old tavern signs.

And, for the visitor interested in a day excursion, Mystic Seaport, a reconstructed whaling port from the days when whaling formed one of Connecticut's principal industries, is an hour's drive southeast of Hartford. Sturbridge Village, a reconstructed colonial American village, is an hour's drive northeast of Hartford.

Souvenir hunters and shoppers at the 1981 Worlds will be interested to know that the Hartford area is the second

largest retail center in New England with more than 4,200 shops. Many are located right in the Hartford Civic Center or nearby on Pratt and Main Streets or at Union Place.

And for the diner, the variety is tantalizing. From the elegant continental restaurants in downtown, to the plethora of ethnic restaurants in Hartford's south and west ends, to antique country inns just outside of the city, to lively restaurants featuring musical entertainment, to casual places to enjoy lunch or supper, and to fast and takeout food restaurants, Hartford has them all.

Access to Hartford's many attractions will be made easier for visitors to the 1981 Worlds staying at non-central hotels and motels by regular shuttle bus service between them and the Hartford Civic Center.

Hartford is a world in itself. That's one reason why Hartford believes that figure skating enthusiasts from around the globe will feel right at home in the Insurance City. Hartford hopes that Hartford will be your home when "Hartford Welcomes the World."

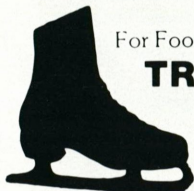

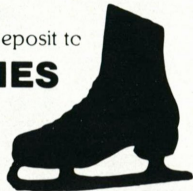

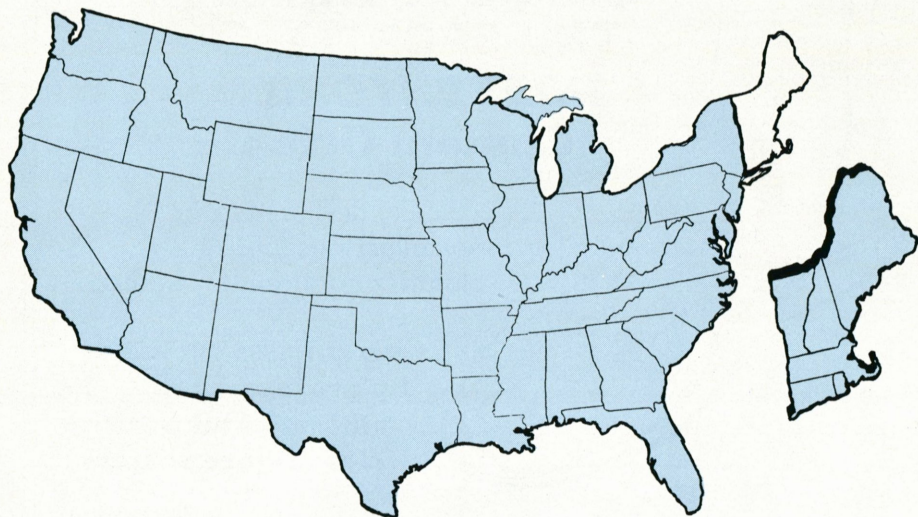

then once without. Practice the hard parts. Re-do unlanded jumps. Work yourself beyond endurance then work just a little bit harder. Your hard work will pay off later on in tests and competitions.

*Homework:* Listen to music. Appreciate art and sports. Look at the world around you and appreciate life and action and nature and people. This is what skating is all about. Low on the list of priority: moping, crying, whining, complaining, martyrs, passing judgement, laziness, weakness, pouting, stubbornness, defeatist attitudes. High on the priority list: activity, smiles, perseverance, hope, patience, loyalty, friendships, dynamic actions, vivacious persons, strong attitudes, understanding, confidence.

*Every night without fail!!!* Plies, leg stretches, arabesques, jumps, (jump rope, hop scotch, jumps in place for height), turns, experiment with arm positions, close the door, turn on the music and dance!

*Doing your program during freestyle sessions:* Little Susie and Linda and Emily all got in your way. Deliberately!

They just stood there! You can: a) stamp your feet; b) yell louder; c) kick the ice; d) kick Emily; e) cry. Or you could skate more forcefully, more positively. Let people know you won't go around them when your music is played. (Remember to be considerate in turn for others). The weaker you are the easier it will be to get run over.

In closing, I would like to say that you all have excellent qualities, each of you is special and part of the world of skating. Make the most of your good points and work hard on what doesn't come easily. You are your own special person, unique and individual and of great importance.
