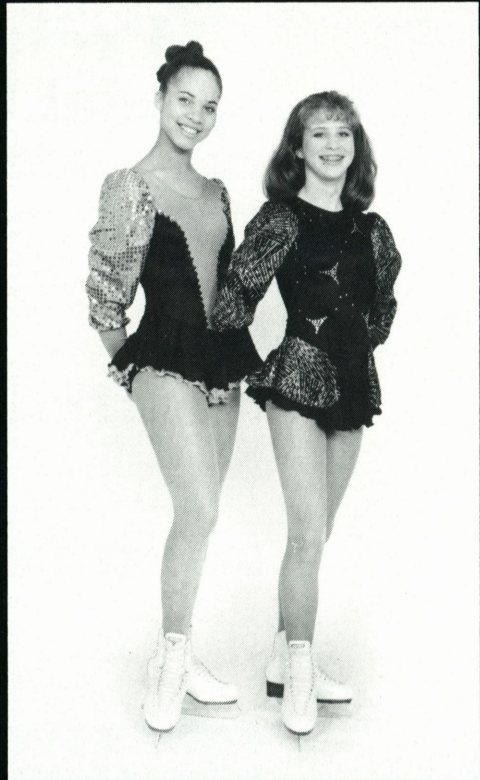
As we enter into this festive season, my very best wishes to one and all for happy holidays and a peaceful and prosperous new year.

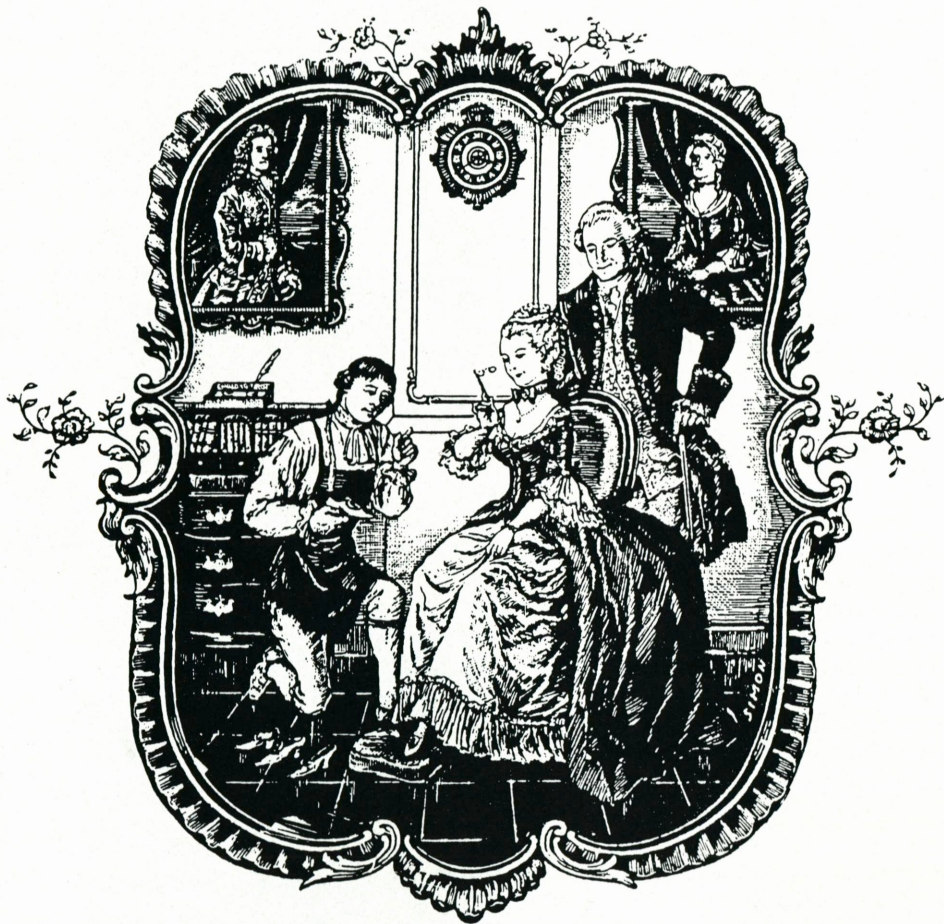

REVIEW

## ON THE ROAD WITH PRECISION

The skates are sharpened and the music arranged. The dresses are designed, fitted, and ordered for the start of another competitive precision skating season. This year our competitions will take us from coast to coast with a few stops in between. Each precision trip should be more than the competition alone. Granted, that is the main reason for traveling to the host city, but overall, we can learn and experience much more.

With the precision skating season rapidly approaching, the coaches, team managers, parents, and skaters should take a closer look at the cities, states, and even countries where the teams may venture. Preparation for a competition may include extra practices, but another type of preparation for a competition should take place six to eight weeks in advance. A simple request letter to the Chamber of Commerce and the Visitor Information Center of the host city will provide valuable information on how you and your team can enjoy your free time. It is important to include in your letter why you are visiting their area and the approximate amount of time you will be there. You can expect to receive a packet with local and neighboring points of interest, city maps, transportation systems, and quality restaurants. At times, you will also receive discount coupons. AAA tour books are also available with multiple listings, maps, and historical information.

Once you have reached your destination organized bus tours are educational adventures to help you get acquainted with the city.

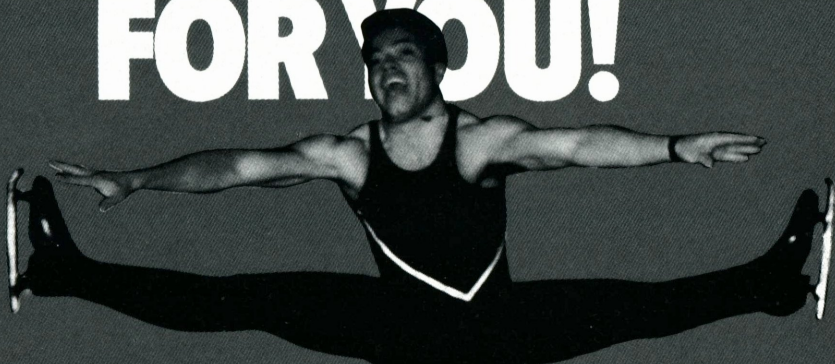

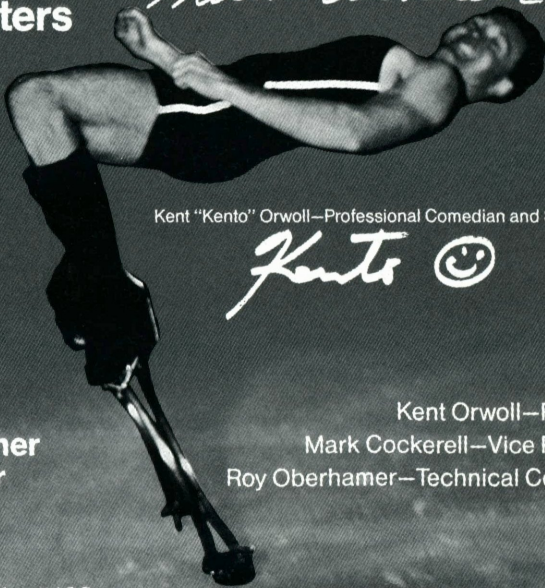

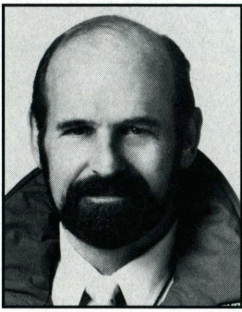

# DICK BUTTON

## Inducted into Lake Placid Hall of Fame

Skating legend Dick Button was recently inducted into the Lake Placid Hall of Fame. He joined 38 other distinguished members, all with strong ties to the town, who have done much to better the community.

Button was the only skater ever to make a grand slam winning sweep of all major titles—two Olympics, five Worlds, seven Nationals, and the now defunct North American Championships. He dominated the sport for seven years.

Proving there *is* life after skating, his horizons branched out in many directions. A graduate of Harvard College and Harvard Law School, he is a member of the bar, and an authority on American decorative arts. He has written a variety of magazine articles plus two books, and for 20 years has been an ABC television sports analyst; winning an Emmy along the way.

He has been an actor, producer of the World Professional Figure Skating Championships, and creator of the *Superstars* television series. He is president of Candid Productions Inc., a major supplier of sports and entertainment programs. He recently produced *Sweet Sue*, with Mary Tyler Moore and Lynn Redgrave, as well as Tom Stoppard's *Artist Descending a Staircase*.

Unable to attend the induction-banquet ceremonies because he was in Spain, he requested Ardelle Sanderson do the honors for him. Sanderson, a

former national competitor and Olympic and World judge for more than 50 years, was inducted with the first group of Lake Placid Hall of Fame members. She reminded the gathering that Dick had performed the first double Axel ever at the 1948 Olympics, and the first triple jump ever at the 1952 Olympics. She also said, "As a sports-conscious audience, you have watched on your TV screens, National, World, and Olympic events. It was commentator Dick Button who educated you on what to look for in free skating. Now everyone who watches knows a triple Axel, or a quad, or a flying sit spin, thanks to Dick."

Following Sanderson's comments, a plaque was unveiled which will hang in the Olympic Center Hall of Fame Room. Then, via videotape, Button delivered a message.

Thanking the people of Lake Placid, he recalled his first glimpse of the village, at age 12. "As we rounded the bend, I first saw the huge rolling roof of the Olympic Arena (built for the 1932 Olympics), where I was to skate for a whole week! It turned into years, and Lake Placid became my second home."

He paid high tribute to his coach Gus Lussi (also a Lake Placid inductee) and Mrs. Lussi. "They taught me everything I know about skating—and life."

Always addressing them as "Mr. and Mrs.," even when he turned professional, the Lussis requested that he call

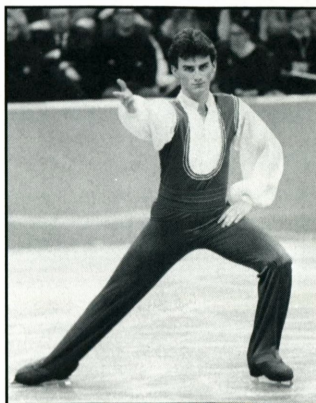
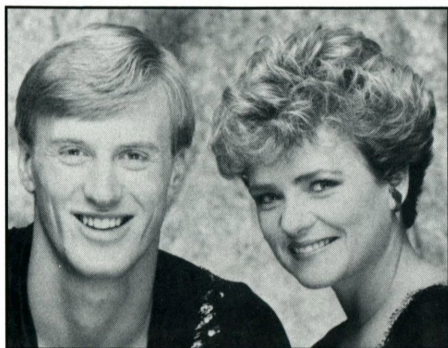

The hot line-up in pairs should thrill any skating enthusiast: Olympic Champions Ekaterina Gordeeva and Sergei Grinkov, and Elena Valova and Oleg Vasiliev (USSR); World Champions Barbara Underhill and Paul Martini (CAN); Elena Bechke and Denis Petrov (USSR), Natalia Mishkutenok and Artur Dmitriev (USSR); and Isabelle Brasseur and Lloyd Eisler (CAN).

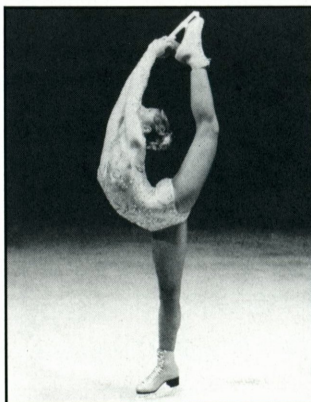

## CONWAY COMEBACK IN BRITISH CHAMPIONSHIPS

Joanne Conway's convincing victory in the British Championships, her fifth title in six years, clinched her return to the national team and to the World Championships, after suffering from injury most of last season.

Now trained by her childhood coach, Debi Monte, following unsuccessful spells in America with Carlo and Christa Fassi, and then Robin Cousins, Conway's resurgence is thanks largely to diligent dieting. She has lost 20 pounds since January 1989, and her trimmer, lighter frame makes jumping easier, putting less stress on her vulnerable lower legs.

Her triumph was even more remarkable following a disastrous warm-up at Basingstoke, in which she fell twice while attempting a triple Salchow. It was also the perfect answer to the suggestion by Cousins two seasons ago that she lacked courage.

Little wonder, then, that the elated 19-year-old punched the air with both fists after her winning free. This just isn't done in the world of skating, but everyone readily forgave her.

"I feel much more mobile after losing weight, and I hope I have turned the corner in readiness for the next two Olympics," she said. In reserve for the women's events is Jackie Soames. She edged ahead of Conway in the original, the judges splitting 4-3 in her favor, but lost her chance when falling on a double Axel.

With two Winter Games in three years—1992 at Albertville, France, and 1994 at Lillehammer, Norway—providing extra incentive, the British team, though small, looks the best it has in several years.

Steven Cousins, the automatic men's choice, is already the best prospect since his namesake, Robin (no relation) retired in 1980. The tall, powerfully-built Welshman landed four great triples in retaining his men's crown and looks likely to be the first Briton to achieve the triple Axel.

Steven Cousins once said he hoped to become as famous as Robin, the 1980 Olympic champion, and his all-around ability suggests he can achieve this. The Cousins name may live even longer, as Robin's two nephews, ages eight and six, have already shown talent in early-grade competitions.

Steven Cousins and Conway could well be among top world contenders by 1994, when they will be 21 and 22 respectively.

Two pairs will join them for the European Championships in Sofia—Cheryl Peake and Andrew Naylor, who won their sixth consecutive national title, and Catherine Barker and Michael Aldred. They will do battle for the only slot available to Munich. The new ice dance champions, Ann Hall and Jason Blomfield, complete the party for both venues.

WORLD FIGURE SKATING MUSEUM

*On February 15, the Target Center in Minneapolis will be filled with the joy and excitement of the 1991 U.S. Championships. In stark contrast, the date commemorates the darkest day in American figure skating history, when the entire World Team perished in a fiery airplane crash in Belgium in 1961.*

*Thirty years ago on February 15, it seemed as though the world had stopped with the loss of the brightest and best of U.S. skaters and that our future in the sport had been extinguished in the flames. The loss was and still is immeasurable. The event is unforgettable.*

# A Day to Remember

The 1961 World Championships had been scheduled for Prague, Czechoslovakia. On Valentine's Day 1961, the U.S. team gathered at Idlewild Airport (now Kennedy International) in New York City for the overnight flight to Europe on Sabena Airlines.

The Boeing 707 was to land in Brussels and the team would continue on to Prague. The flight departed at 7:20 P.M. carrying 18 skaters and 16 officials, coaches, and family members. Also on board were 27 other passengers and 11 crew members.

As far as is known, the flight was routine. There was no sign of trouble as the plane crossed the Belgian coast the next morning. The pilot radioed the Brussels airport stating that everything was operating normally and then requested landing instructions. It was the last communication from Flight 548.

The jet came into sight over the control tower a little before 10:10 A.M. and was put into a holding pattern while another plane departed. After circling twice, the plane descended to 600 feet on the final approach. The landing gear was lowered, then inexplicably retracted. The approach was aborted and the plane pulled up sharply and began to climb.

The control tower could not make contact with the pilot. There were unusual engine sounds and the plane made several zigzag turns and began to shake. It then nosed over and fell into a series of spins.

There was a tremendous explosion on impact, and it literally disintegrated in a field near the small village of Berg four miles from the airport. A series of thunderous explosions followed, one by one. A farmer working in his field nearby was

killed by flying debris; another man's leg was severed. There were no survivors.

Messages of condolences poured in from around the world. President Kennedy issued a statement, "The disaster has brought tragedy to many American families and is a painful loss to the international community of sports as well. Our country has sustained a great loss of talent and grace, which have brought pleasure to people all over the world."

The skaters already gathered in Prague were stunned by the news and there were rumors that the Championships might be canceled. F. Ritter Shumway had been acting president of the USFSA for only three weeks following the sudden death of Howard D. Herbert. He wired ISU President Dr. James Koch requesting that the competition be held. "I know the skaters would want it that way."

The ISU Council voted by cable on a Swiss proposal and George Häsler, honorary secretary, announced on February 16, that the Council had agreed to cancel the World Championships "as a sign of mourning over the deaths of our United States comrades."

"We are deeply moved by the expression of sympathy," Shumway replied. "The sincere feeling of fellowship eases the burden that all of us in the United States feel and indicates the high personal regard in which our skaters were held throughout the world."

One by one the skaters left Prague. The 1961 season was over.

It had been an important year for the U.S., a year of building and growth following the 1960 Olympics and the retirement of all Senior national champions. The futures of the new champions had

looked bright, but the great expectations for Prague ended in a field in Belgium on a clear blue morning.

However, like the legendary phoenix that rises anew from the flames, the rebuilding of the American skating program was undertaken with great diligence and dedication and by the 1964 Olympics, in three short years, the U.S. took medals in men's (Scott Ethan Allen, bronze) and dance (Vivian and Ronald Joseph, bronze), firmly establishing its return as a dominating force on the international scene.

New 1961 U.S. Dance Champions Diane Sherbloom, Los Angeles FSC, and Larry Pierce, SC of Indianapolis; Donna Lee Carrier, Los Angeles FSC, and

Roger Campbell, Arctic Blades FSC, national dance silver medalists and North American champions; and Mrs. Ann Campbell, mother of Roger. Husband and wife, Robert Dineen and Patricia Major, national dance bronze medalists, SC of Lake Placid.

Among the professionals and officials who perished was Maribel Vinson Owen, mother and coach of Laurence and Maribel Y. Owen. She was America's foremost skating personality, having been both the U.S. Junior Ladies and Pairs champion, nine times U.S. Ladies champion, six times Pairs champion, North American Ladies and Pairs champions, a member of three Olympic Teams, winning the bronze medal in 1932 and the World silver medal in 1928. She had served on numerous USFSA committees, authored three books on figure skating, and was the first female sports writer for *The New York Times*.

Walter S. Powell, world referee, St. Louis FSC, and former USFSA president; Harold Hartshorne, world dance judge, five times U.S. Dance champion, SC of New York, and his wife Louise. Deane E. McMinn, team manager, Arctic Blades FSC; Edward LeMaire, national judge, SC of New York, and his son Richard. Edi Scholdan, one of the country's top coaches, Broadmoor SC, and his son James; William Kipp, coach from Paramount, Calif.; Daniel C. Ryan, professional of WC of Indianapolis; C. William Swallender, professional from Detroit, Mich.

No monument bears their names, but each is held in honored remembrance and shall never be forgotten. Through the USFSA Memorial Fund, founded following the tragic crash, the spirit of the 1961 World Team continues to enhance the sport and the champions of today and the future.

# A Living Memorial

Feb. 15, 1961 — Feb. 15, 1991

Over the past 30 years the USFSA Memorial Fund has provided assistance to literally thousands of U.S. skaters—financial support for training and skating expenses, as well as assistance with educational costs which now total in the millions of dollars. In each of the past several years the activities of the fund have supported over 200 skaters with the total amounts, in both grants for skating expenses and academic scholarships, reaching close to a quarter of a million dollars annually.

## Where does the money come from?

Funding for the Memorial Fund comes from a variety of sources. Under the leadership of longtime Memorial Fund Chairman F. Ritter Shumway, who was president of the USFSA in 1961 (and is also now a member of the World Figure Skating Hall of Fame), the Memorial Fund has developed a financial reserve, interest from which provides funds for annual operations. In addition, however, the Memorial Fund receives monies from USFSA Board appropriations, private donations, through gifts from wills and trusts, club shows, exhibitions, donations received in memory of or in honor of, direct fund-raising mail campaigns, and the sale of Memorial Fund tokens, patches, decals, bumper stickers, and posters. For the 1991 Anniversary Year, the Memorial Fund will have special commemorative items available for skating supporters such as: tokens, decals, bumper stickers, and posters. For the past couple of years, the Memorial Fund has produced a poster of the U.S. World Team which has been very popular for

display at clubs and as a gift to young skaters (and has raised some additional money for the Fund). A special 30th anniversary edition is planned for 1991.

## Where does the money go?

The Memorial Fund supports the skaters on the U.S. World Team. They receive the largest individual amounts of funding, but the *majority* of the financial support from the Memorial Fund is received by Novice and higher-level competitors. Grants are made annually to those skaters by a subcommittee of Memorial Fund officials based upon information they provide in applications including financial need and the committee's judgement of their dedication and promise of future development. For 1991, however, as a special activity to mark the Fund's 30th year, an award from the Fund will be made to every skater competing at the U.S. Nationals in Minneapolis.

For many years the Memorial Fund made loans available to skaters as well as grants of financial support. This program was discontinued several years ago. Because of additional support available to the Memorial Fund, it was able to increase the amount of funding made available as direct grants to skaters so that, at the end of their competitive careers, skaters would not, in addition to educational expenses, have loans for past skating to repay.

Obviously some of the skaters who have received support from the Memorial Fund have gone on to achieve the highest levels of success in our sport. Readers of *Skating* magazine probably recognize

their names, and the Memorial Fund is very proud not only to have supported these champions when they needed its assistance, but also that so many of them have been willing to aid the Fund in its efforts to raise monies so that succeeding generations of competitive skaters can receive support. JoJo Starbuck and Ken Shelley, Linda Fratianna, Scott Hamilton, Peter and Kitty Carruthers, Brian Boitano, Natalie and Wayne Seybold, Susan Wynne and Joseph Druar are all Olympians and professional skating stars who have worked with the Memorial Fund in its fund-raising efforts. The donor list of the Fund includes many other well-known skating names: Dick Button, Tenley Albright Blakely, Peggy Fleming Jenkins, Elaine Zayak, Debi Thomas and many, many others.

Current competitors have also been willing to work in support of the Memorial Fund. April Sargeant and Russ Withersby sent thank you letters to donors this year. "I'll sign as many as you send me!" April promised and didn't let the fact that it became hundreds deter her. Jill Trenary helped sell posters at the USFSA Governing Council meeting in Indianapolis (and autographed them as quickly as they were sold).

Many former USFSA championship skaters are quick to note how much the initial Memorial Fund support they received helped them and, in turn, they're now assisting other skaters. Although the amount probably wasn't very large, it's obvious how much it meant at a time when they were just beginning their careers, when support from the Memorial Fund showed, more than anything else, that "someone up there" had noticed them and their efforts in skating.

Competitive skating in the U.S. has come a tremendous distance in 30 years. The USFSA Nationals, once held at local clubs or small arenas (there is an abso-

lutely charming sequence on a film of Carol Heiss winning a Nationals in the late '50s showing the judges seated on folding chairs on the ice) are now scheduled for major facilities and the championship events are often televised live nationally. What has happened to the thousands of skaters the Memorial Fund has assisted over that time? A handful have been fortunate enough to become National champions, Olympians, or professional stars, but the overwhelming majority never reached the medal platform at Nationals. Today some are coaches, parents of skaters, or fans in the seats and at home in front of TV, and they've become the backbone of the increased support figure skating has enjoyed over the past three decades.

The Memorial Fund hopes to make 1991, the 30th anniversary year, very special. Recognition of the competitors at Nationals is one part of that program. None of these skaters were born when the plane carrying the U.S. World Team, coaches, officials, families, and friends went down on February 15, 1961. The activities of the Memorial Fund, intended as a living memorial, rather than a plaque, a statue, or even a building, have allowed those victims immortality by helping generations of competitive skaters who have succeeded them. The 1961 U.S. World Team will live forever in our memories through the continuing activities of the Memorial Fund.

### *On "The Second Mark" —The Original Program*

The second mark of the Original Program is for presentation. In order to be "presentable," you need the physical basics on which to build your work, such as: good posture and carriage, control, stamina, coordination, strength, stretch, and definition of line and form in space.

Good posture is one of the main ingredients of presentation. If the torso is sagging, there is a weakness to the program. The arms lose their power; the head is not in line and the buttocks may be sticking out. An introverted chest on a male skater is very unattractive, and a female can look 10 pounds heavier just by slumping! Bad posture affects jumps in the landing position particularly, and it is not pleasant to watch. Emphasis on good posture should be placed early on to avoid the mishaps bad posture brings.

Control comes from the proper use of muscles and training the body to use only the muscles needed for each move. If too many muscles or too many parts of the body are in use at one time, a lack of control results. When a skater can hold a jump landing on a clean edge for three or more counts, he is demonstrating control. The same control is shown in spins if they are centered on the ice, and not traveling. In stroking, the arms should not sag, but should be held up in line with the shoulders; the upper back supporting them.

If the skater loses stamina before the end of the program, not only will the quality of the elements be weakened, but the presentation seems to fly out the window. This tells you there is a flaw in the training process of this skater. Stamina is one of the easiest, of all of the aspects involved in skating, to accomplish and it remains the responsibility of the individual skater. He must want to develop it by climbing stairs, jumping rope, skating laps, or through any other number of endurance-building activities. Everything else will seem so much easier.

Lack of coordination is easy to detect when movements don't seem to be in synch, or it appears difficult for the skater to skate fast while moving his arms or head at the same time. When coordination is not there, the jumps are also a bit off as everything must work together. Young skaters can start doing simple arm movements to the counts of three and four on even crossovers in circles.

Weakness shows quickly in the upper torso. Other weak spots can be detected in spiral positions, landing positions, height of jumps, and in getting the knees down into the ice while stroking. The skater can perform a perfect program, but if strength is not shown, the presentation is weakened, and it looks like he is tiptoeing through the program. Strengthening exercises, especially of the quadriceps, upper back, and upper arms, are very important.

Stretch is also very important for an artistic look and good presentation. If a skater cannot get her leg up above her hips, or keep the upper torso arched, presentation in the spiral sequence, and in many of the spins, will be lacking. Stretch and stamina are easy to accomplish. It just takes daily practice and consistency. If it is not there, the skater is usually lazy, and probably not following the coach's directions. Skaters have to do it themselves—every freestyle session—and do it correctly. If they stretch incorrectly it can negatively affect many parts of their program, including jump landings.

Ballet automatically trains the body to have good line and form in space. "Attitudes" will have the proper turn-out, as well as spirals and camel spins. Also, the toes will be turned up rather than pointed down to the ice, as is seen so frequently. The back must be strong so that the shoulders are even in laybacks, and the body pulled up without the buttocks protruding, or the skating knee bent. On all arabesque positions, the correct arms will be properly placed on the line of the legs.

If all the physical aspects of the body are trained properly, good presentation is easier to accomplish, and the second mark will go up.

# GORDEEVA & GRINKOV:

## Starting a New Life

The ponytail is gone and along with it the smile, the charisma, and the strength. There are doubts now and imperfections. The smile when it comes to her face is more forced. A new Ekaterina Gordeeva is emerging.

Gordeeva is now 19 and no longer a little girl. The constant attention has been difficult. She often has been weary and unsure as her body continues to change and grow. She has transformed from an adolescent into a woman.

Gordeeva had hoped to be in the 1992 Olympics, but she said she hasn't the strength to continue. The many injuries

and illnesses over the past few years—a concussion suffered three weeks before the 1988 Europeans, knee injuries that kept her out of the 1989 Europeans, and the cold that lost the World Championships in 1988—are indications that Gordeeva is much more fragile than she appears. Fragile not only physically but mentally.

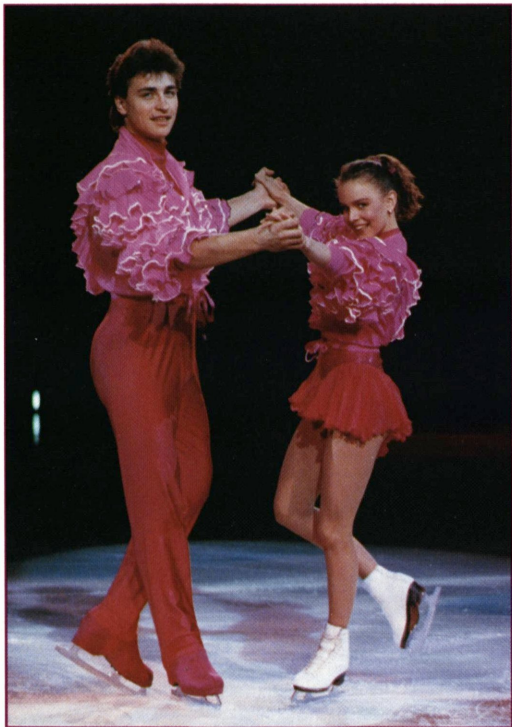
She is a worrier who worries about what others think. She tries to please those around her—her coach, her partner, and her audience—by putting their needs before her own. She is distracted. The perfect programs seem beyond her control.

Gordeeva along with her partner, Sergei Grinkov, will not be the 1992 Olympic champions. The pair will not be defending their World title in 1991 but instead competed in the 1990 NutraSweet World Professional Championships in Landover, Md., in December.

Said Gordeeva of their decision not to continue in the European and World Championships, "The competitions for each year get more and more difficult because we are not in the championships for the first time. There are many young pairs progressing. I feel the fatigue building up."

"She is growing up and skating to be mature so the situation has now changed," explained coach Stanislav Leonovich. "Before I could go out and do it without thinking," added Gordeeva. "Now I must think about it."

Gordeeva began skating at the age of 4 and Grinkov at 9. Grinkov's parents both work for the Moscow police. Gordeeva's mother is a teletype operator for TASS,

the official Soviet news agency. Her father is a dancer in the Alexandrov Song and Dance Ensemble of the Soviet Army. From an early age, Gordeeva said her father worked with her on movement and feeling for the music.

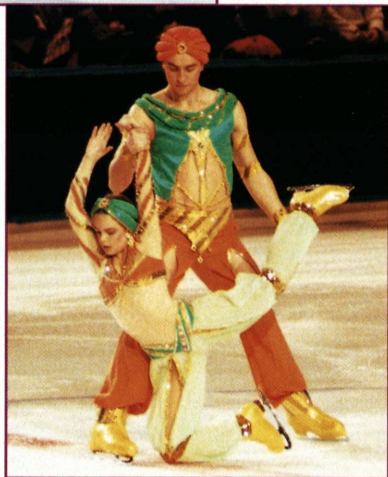
Grinkov started as a singles skater but he said he was so terrible that he had no choice but to try pairs. He was paired with Grinkov when he was 15 and she was 10. He admitted that he did not want to skate with her at first. But as often happens in the Soviet Union, he had no choice. Gordeeva was his partner and he the only partner she has ever had.

Four years later, the pair was the best at Junior Worlds and also won Skate Canada over more experienced pairs. But at home, they were no better than sixth in their national championships behind 1984 Olympic Champions Elena Valova and Oleg Vassiliev and Larisa Selezneva and Oleg Makarov who won the Soviet championships that year.

In 1986, Gordeeva and Grinkov entered the European Championships for the first time and were beaten only by Valova and Vassiliev. In their first World Championships, they were the champions.

Their early wins were marked by dazzling technical display such as a quad split twist where Grinkov hoisted Gordeeva nearly to the rafters. Gordeeva floated in the air like a feather until she came down in Grinkov's arms. Gordeeva was just 4'10" at the time and weighed only 79 pounds. Grinkov was more than a foot taller and nearly twice her weight.

The win over the defending champions was labeled as quite a sensation. Said Moscow's Central Army Sports Club skating coach, Victor Ryzhkin, "It is usual for our Olympic champions to retire before they are beaten." From then on, Gordeeva and Grinkov were heroes at home and mobbed wherever they went in the Soviet Union.



What set Gordeeva and Grinkov apart from the others was their naturalness. Grinkov was the silent leading man. Gordeeva, or Katya as she is nicknamed, had the freshness and smile that slew hearts. Even the grim Grinkov could not avoid smiling back at Gordeeva when she caught his eye and smiled at him.

The couple acquired many nicknames, the beanpole and the mite, the guerrilla and the flea, the dimpled doll and the gallant prince, but what they had was the gift of perfection. By 1987, they were awarded the title "unbeatable." That is when bad luck struck.

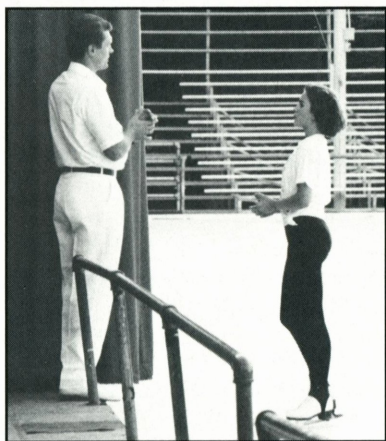
Skating at the European Championships, Grinkov's bootstrap came loose. The music was stopped and the referee motioned for them to discontinue their program. The couple refused, finishing in silence. The referee ordered that their program be reskated. The pair refused and was disqualified.

A month later, they returned to win the World Championships showing that they were the best in the world. The Olympics the following year, in 1988, was a repeat of perfection. Said choreographer Sandra Bezic of their Olympic performance, "It was heaven. He presented her so beautifully like a cherished little sister. They are everything pair skating should be." Toller Cranston said, "When Gordeeva and Grinkov skated, there was no contest."

After 1988 the problems began. Gordeeva's mother is a statuesque 5'10" and many wondered whether Gordeeva would grow to be close to her mother's height. Although Gordeeva eats very little, not even the cookies she likes to make for her teammates, Gordeeva had grown more than three inches over the last two years and more than an inch over the last year, and gained more than 10 pounds.

The first technical feat to be abandoned was the quad twist. Side-by-side jumps were becoming more difficult for Gordeeva. Her injuries and illnesses and rapid growth were taking its toll. Her confidence was taking a beating. When asked how long the team would continue skating, Gordeeva answered, "As long as we are still young." When further asked if Grinkov might not grow too old for her and she might find another partner, she looked insulted and said, "I don't need another partner."

The partnership, however, exists only on the ice. "We only practice together," said Grinkov. Grinkov chooses to spend his time playing hockey when the competitive season is over. And he has been

labeled as the "Christopher Bowman of the Soviet Union."

Gordeeva is still a young 19, wishing to spend her Saturday nights quietly with her parents and her sister. She said her mother is her best friend. She prefers jeans and tennis shoes or long skirts if she has to dress up. She prefers the quiet to the public eye.

As 1989 and 1990 wore on, there were more imperfect performances and more criticism coming their way rather than praise. They narrowly won the 1990 World Championships with a 5-4 decision over Canadians Isabelle Brasseur and Lloyd Eisler in a controversial decision. The usually unemotional Grinkov was hostilely defending his partner's and some of his own mistakes.

As Gordeeva and Grinkov head toward professional competitions, there are new audiences to win over and new characters to be played. Hopefully Katya will learn again that the audience does not expect perfection. All that is expected is that warmhearted smile that says, "I am here to make you happy."

# Tai Babilonia & Randy Gardner

## Champions Revisited

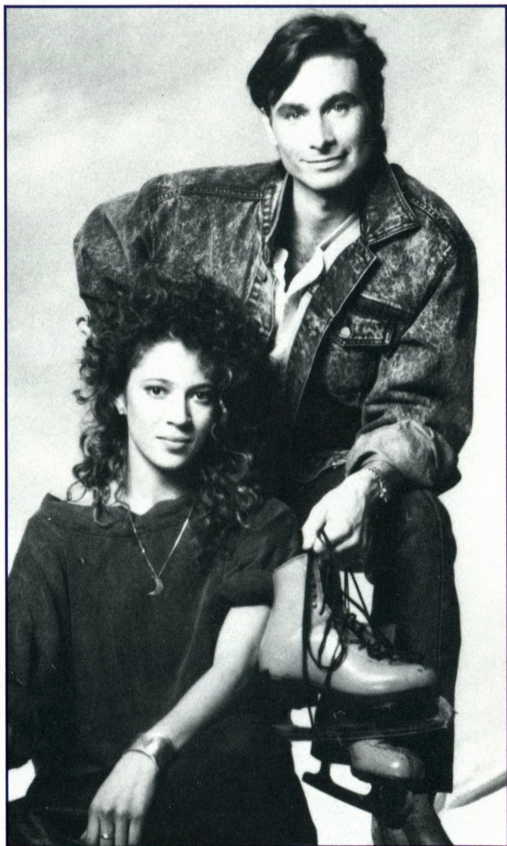

**B**ack in December 1986, *Skating* published an article on Tai Babilonia and Randy Gardner, by this writer, titled, "Tai and Randy: Hotter than Ever." Regarding their perspective at that time of their last-minute withdrawal from the 1980 Olympic Winter Games at Lake Placid, due to Randy's groin injury, the article stated, "Tai . . . and Randy . . . have long since recovered from the effects of that devastating period," and went on to quote Gardner, who had declared, "We're not the 'Heartbreak Kids' any more, which people used to call us. We never even think about what happened. All the disappointment, the bad feelings are gone, due mainly, I think, to the fact that we were able to continue skating."

Babilonia had added, "We're both pretty strong people mentally. We didn't want to dwell on it. We just wanted to go on with our skating, because we love it so much."

As the world knows by now, for Babilonia those "bad feelings" were not really gone at all, despite her sincere belief that all was well. Instead, she had blocked her emotional pain as surely as Gardner's last-resort shot of Xylocaine had masked the pain of his injury at the Olympics. In the post-Olympic years on the road, with Ice Capades, Fantasy on Ice, Festival on Ice, and other professional shows, she found an escape in amphetamines, alcohol, food, and a string of romances with such performers as Christopher Knight, Andy Gibb, and Christopher Penn; she was even engaged for a time to Peter Carruthers.

The years of substance abuse and self-abuse culminated in September 1988, when, shortly before her 29th birthday,

she swallowed sleeping pills in a suicide attempt. She became frightened, though, and phoned her mother and her manager. She has since been in therapy and in 1989 made a successful comeback with Gardner, with a six-week engagement at Bally's Grand Hotel in Atlantic City, N.J.

In April 1989, Babilonia told her story as the cover subject of *People* magazine. That same week, manager Michael Rosenberg closed a deal for a television movie about her life. Called *On Thin Ice*:

*The Tai Babilonia Story*, the film starred Canadian actress Rachael Crawford as Tai, Charles Stratton as Randy, William Daniels as their coach John Nicks, and Denise Nicholas as Tai's mother Cleo. A chronicle of the emotional roller coaster Babilonia rode before, during and after the Olympics, the film aired November 5 on NBC, finishing 37th in that week's ratings.

Sitting now with Gardner in their publicist's West Hollywood office, Babilonia shows no sign of the duress of the past decade. Her long hair is brown once again—for a time, at her most desperate, she had dyed it purple to ensure that no one would want to book her to skate. Now 31, she is sleek and svelte, laughs often and banters back and forth with Gardner, 33, their publicist, and this writer—a far cry from the shy, withdrawn Babilonia of her troubled past.

Both she and Gardner, though, quickly turn serious when discussing the events of that past. "I'm still picking up the pieces," she said. "It's a slow process, but that's the way to do it."

She wanted to make the film, she noted, to let others know that "Everyone goes through their ups and downs. Everyone hits rock bottom at some point, or near it. The message is, 'If I can get through it, so can you.' It's as simple as that."

Doing such a film also became a unique way to exorcise some of her own demons. As consultant, she spent the entire month of production last August on the set in Toronto, and with Gardner, doubled the skating sequences, which he staged and directed.

"After the first week, I was ready to come home," she recalled. "I panicked, freaked out, called my boyfriend and my manager and told them I was coming home. They calmed me down. I'm glad I stayed. It was very therapeutic, though after the month was up, I was drained.

But I feel now like I've been cleansed, like I'm starting over."

There were some days, Babilonia admitted, that she could not bring herself to visit the set. "I knew I just couldn't watch the taking of the pills, the ambulance scene, Randy taking the shot. But other days, I was fine. I liked being there because I could talk to Rachael if she needed to ask me questions."

Ten years later, how did Gardner feel about recreating that awful night in Lake Placid?

"It was physically hard, first of all, because I fell on my bum a lot," he replied. "The first few times it was okay, but then I got really tired and the emotional drain set in. I had to push myself the last couple of takes. Throughout the film, I thought I was pretty good separating myself from what really happened, but there were certain things I couldn't

do. As much as I tried to separate this from real life, it was still hard, there was still that connection.”

Even the far more positive clips, such as their winning the Pairs event at 1979 World Championships, were “bizarre” to stage, Babilonia said. “It was so weird, just going back in time. For Worlds, we had the same color costumes, matched to a T. I had to paint my skates white again, which was strange. And you can’t try to top that performance—it was a once-in-a-lifetime thing. We sort of fought it—I’d fall, then we’d both fall, and this was in front of a live audience. So we said, ‘Okay we’re just going to go for it, pretend we’re 18, 19 years old again.’ But it was very difficult.”

Both say that overall, the reaction they have received about the film has been positive; Gardner noted that his skating friends mentioned the film’s little inaccuracies, but that everyone enjoyed the skating sequences.

The day the film aired, Babilonia, who now lives in Santa Monica, took refuge in Santa Barbara with her boyfriend, drummer Cary Butler. “There were 19 phone messages on my machine that day—didn’t know it held that many!” she reported. “People came out of the woodwork—people in skating, people who had no idea I was going through all that and were sorry they were not there to help. They were all very supportive.”

“I called my parents from Santa Barbara,” she added. “I didn’t get much reaction from them, or from my brother—I guess they were shocked to see everything so magnified. My mom said, ‘Tai, I really want to know how you are mentally, and health-wise.’ So I said, ‘I don’t take the pills. I’m a vegetarian now, so the weight stays off. And I guess I’m a natural neurotic.’”

Since the film aired she has received at least five letters a day, she said. “They’re incredible. They tell me about their problems, and how they coped with them. That’s why I did this movie.”

Those who watched the film may have wondered why it focused almost exclusively on her, when, after all, Gardner was the one who suffered the trauma of the actual injury and whose own career was jeopardized by her travails.

“There were technicalities why they couldn’t do more on me,” Gardner revealed. “I didn’t actually give my consent to do *my* story—this was her story. I’m not ready to . . . I don’t feel I have to explain my life and career. I really admire Tai for initiating and contributing to this movie. I can’t imagine doing that—how much you have to let go of yourself. But I cooperated as much as I could with the project. It was very tricky, but I think they did a good job.”

He is ready, though, to comment in print as to how Babilonia’s problems affected him. He had gone to the hospital immediately after being notified of her suicide attempt, later attended a therapy session with her, and has been a steadfast friend throughout her recovery.

“It was scary at the time, real scary,” he said. “I didn’t really know what was going to become of skating with her, because she didn’t really know. It was an open-ended thing. It was frightening to me, but it also forced me to make decisions to do things. I’ve been fine. I’ve been happy with what I’ve been doing.”

His subsequent solo activities have included performing at Sun City, South Africa, directing the Christmas ice show at Knott’s Berry Farm for the past two years, and choreographing the San Diego Sea World’s summer ice show. He is currently directing and staging a new theatrical ice show, which kicks off with a showcase at

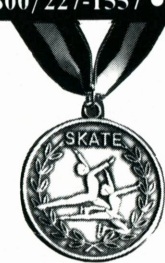

**REPORT OF ACTION  
taken by the  
USFSA GOVERNING COUNCIL  
at its  
ANNUAL MEETING  
held in  
INDIANAPOLIS, INDIANA  
May 11 and 12, 1990**

The Notice and written reports of the Officers and Committee Chairmen presented to the 1990 Annual Meeting of the United States Figure Skating Association Governing Council are contained in the Report Book of the meeting. The actions of the Governing Council with respect thereto are summarized below.

The Governing Council took the following actions:

**President**

1. Elected the following Probationary Member Clubs to Permanent membership in the United States Figure Skating Association: SC of the Finger Lakes, Genesco, NY; SC of Lake Forest, Lake Forest, IL; North Star FSC, Northboro, MA; Skate Company SC, Lincoln Park, MI; Southwest Michigan SC, Kalamazoo, MI; and, Swan City Ice Skaters, Beaver Dam, WI.
2. Approved a resolution by Mrs. Joan Gruber honoring the 1990 World Team and directed that a copy be sent to each person.
3. Approved a resolution by Mrs. Joan Gruber honoring the 1990 World Junior Figure Skating Team and directed that a copy be sent to each person.
4. Referred proposed change to Bylaws found in Exhibit A back to committee.
5. Approved that information concerning proposed changes to meeting structure be made available to all delegates to the Governing Council.

**Eligibility**

1. Approved the reinactment of the Interim Eligibility Rules as revised and presented for the period from May 13, 1990 to May 12, 1991.

This item was declared urgent.

2. Approved under Competitions to amend the Alternates Rule down beyond 6th place to the last, if necessary.

The Governing Council overruled the Board of Directors.

**Competitions**

1. Approved offering Fours at Nationals if it is restricted to Junior and Senior levels, i.e., if the minimum qualifications are those for Junior Pairs.
2. Approved under CR 35.033 that entries for Regional Championships shall close 45 days before the day the Regional Championships begin.

This item was declared urgent.

3. Approved CR 35.042 to read at the close of entries, if there are four or fewer competitors in any event of a Regional Championship, the skater may progress directly to Sectionals: if any two of the four wish to compete, the event will be held and it will not affect the eligibility of the third and fourth skater to advance to the Sectional competition.

**Precision**

1. Approved an extra \$50,000 be set aside for funding Snowflake International Precision Competition (this is in addition to any Olympic funding).
2. Approved that \$100 per skater be granted to each skater as a subsidy for 1991 Precision Nationals in Anchorage.

**Member Recognition**

1. Approved that those honorees this year with 50 years or more of judging activity shall be excused from the requirement to attend judges schools or take the annual judges exam.
2. Recognized the efforts of Barbara Holland on behalf of the member recognition.

## Membership

1. Elected the following Interim Probationary Member Clubs to Probationary Membership in the United States Figure Skating Association: SC of Bucks County, Warminster, PA; FSC of Kentucky, Louisville, KY; Shoreline Figure Skaters, East Haven, CT; Tri-Cities FSC, Kennewick, WA; SC of Wayne, Wayne, MI; and, Yonkers FSC, Yonkers, NY.
2. Approved the reinstatement of the Muskegon Skating Club of Muskegon, Michigan, as a member club.
3. Approved the placing of the Interboro FSC of Brooklyn, New York, on the list of inactive clubs.
4. Approved the disbandment of the Newbridge Road Park FSC of Bellmore, New York.
5. Approved that the minimum number of USFSA Member Clubs required to form an Inter-Club Association and be listed in the USFSA Rulebook shall be three (3) clubs.

The exception to this rule shall be those states that only have two (2) clubs be allowed to form an Inter-Club Association.

6. Approved the recommendation that the Membership Committee investigate the trend in membership numbers, come up with suggested programs to promote membership enhancement.
7. Approved the request to change MR 12.013 to include builder, supplier, and consultant.

## Athletes Advisory

1. Approved recommendation to hold a media training seminar at next year's nationals.
2. Approved that an amendment to the By Laws be drafted to provide that all USFSA committees shall have 20% representation by athletes in keeping with the Amateur Sports Act of 1978.

## Long Range Planning

1. Approved the formation of a high level ad-hoc committee to study the ISIA merger opportunity.

## New Business

1. Approved Garfield Heights FSC Senior Precision Team be invited to skate an exhibition at the 1991 U.S. Nationals in Minneapolis.
2. Elected Officers, Member At-Large, Coaches, Athlete Members, ISU Representative and Olympic Representative per Attachment B.
3. The President appointed Standing Voting Committees, Finance Committee, Past President, Standing Non-Voting Committees, and Special Committees as recommended by the Nominating Committee per Attachment B.
4. The President appointed Dr. Harland Burge to be Chairman of the Nominating Committee for the next year.
5. Approved all business of the Officers and Board of Directors from the past year, unless otherwise noted.

If possible, include stops at main points of interest which reflect the history and tradition of the city. These stops will provide an opportunity for many "Kodak moments" between you and your friends. Be sure to ask questions, the tour guides are usually willing to contribute personal experiences and information. If your time and coach's approval permit, you may want to return to a favorite site. Imagine how memorable a precision competition in Boston would be if you were able to walk the Freedom Trail, tour the U.S.S. *Constitution*, and stroll leisurely through Faneuil Hall and the adjacent Quincy Market.

While attending a competition in a new and appealing section of the country or of the world, skaters can learn a great deal about the area they are visiting and about its people by merely walking around. Always travel in a group with an accompanying adult and have the permission of the team management. The mannerisms, attitudes, and behavior patterns of local people teach us a great deal about a region of the country. Think back and recall last year's Precision Team Nationals held in Houston. Remember the people in Texas and try to compare and contrast them with the people we will meet at this year's Nationals in Anchorage.

At a competition where teams from other nations attend, it is entertaining to talk with other team members and their parents. Often skaters will develop a friendship and the international door opens with letters, gifts, and correspondences. Language may possibly be a barrier, but frequently skaters from other nations speak and write English. Remember that smiles and tears are part of an international language.

On special trips, a written journal should be kept. Include the humorous, new, and exciting experiences that you as a team enjoyed. Factual information such as team placements, judges, and formal activities should also be included to make the journal complete. Taking pictures and organizing them in a photo album is another great way to remember your team's competitions. Pictures capture emotions and bring back personal memories of your precision skating adventures.

We know you do not want any extra weight in your luggage, but your school books should accompany you on a trip. Your relaxing time is a prime opportunity to do several math problems or read a chapter for the dreaded book report that is due on the day you arrive home. If you do not want to tote the extra weight of a textbook, invest 25 cents and copy the material you will need. The hours spent on the plane provide a convenient time to get the school work done so you can more fully enjoy your competitive event.

In 1991 the Precision Nationals will be held in Anchorage. Soon, another city will be invaded by hundreds of precision team skaters building memories of the competition, host city, and old and new friends. I'm sure our paths will cross at the rink, in the hotel, or the streets of Anchorage. We may all see our first glacier and I hope we can all do it together!

the Knight Center in Miami this February 13 through 17, and will tour North America later this year and in 1992.

Together, he and Babilonia recently hosted the Jimmy Fund exhibition at Harvard for the second consecutive year, and joined other top skaters to perform in a Disney Christmas television special from Squaw Valley, which aired on CBS.

She has no other specific performing plans as yet. "If something really special comes up, like a benefit or a TV special, I would love to do it," she said. She also wants to publish a book—perhaps geared to children, with illustrations by Toller Cranston, or one combining photos of her life in skating with her poetry. And she continues to market her line of jeweled butterfly pins and hair ornaments that she began creating as a late-night alternative to bar-hopping on the road.

Gardner also wants to branch out. "I would never run from skating—it's been too good, a wonderful thing," he said. "But I'm interested in doing other things—producing skating and non-skating shows. So this movie was a real learning experience, I absorbed everything."

Overall, then, how are things for Babilonia these days? She repeated her earlier assessment. "I'm getting there slowly, taking things one day at a time."

"Looking back," she went on, "I don't think I could have done it without the support of my family, and of course, Randy and the fans. All the fans' letters have been incredible, and I'd really like to thank them. They've really been great to both of us."

Ironically, the same partnership which inadvertently caused her such grief has also been her mainstay, she added. "Randy and I have been together 22 years now. That's a long friendship, a lot

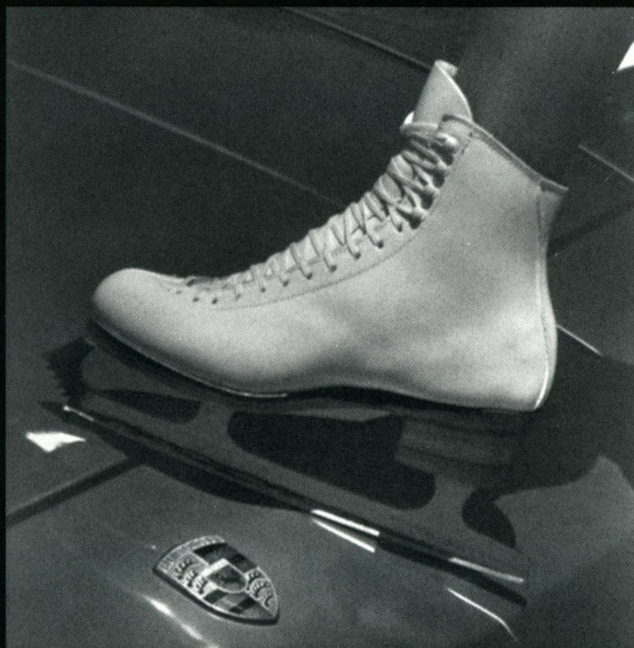
